121. Chairman's Report

The Chair reported that plans for the landscaping in front of the shops at Westfield were being drawn up by Bath and North East Somerset Council and the formal consultation will take place after Christmas. Once this is in place it can be added to by the Parish Council over the next few years and the Council may want to be involved in the In Bloom competition.

Work is in progress by Norton Radstock College on the noticeboard and logo.

122. Bath and North East Somerset Councillors' report

Cllr Moss reported that Bath and North East Somerset Council had taken the decision last month not to roll out the superfast broadband scheme. Fourteen Councillors had said this was wrong and they took evidence from eighteen different people and organisations and told the Cabinet to look at it again. A number of businesses were being restricted by the slow broadband speeds and also BT were giving no indication when the fibre optic broadband would be available. The Cabinet will now look at it again.

Cllr Appleyard reported that the Bryants development is well on the way to being completed and some of our residents could be moving in by January/February. The revised application for Alcan is in the process of being looked at and information on the new road layout in Radstock is available and there is another meeting being held on Wednesday night for the Traders to discuss the plan.
