Comments from the Public:

- (1) One member of the public raised concerns about the roundabout at Glebelands, which has been planted up with daffodil bulbs to create some colour in the Spring. These plants have all been damaged by vehicles cutting across the roundabout instead of using the road properly and by vehicles parking on the roundabout.
 - He also wanted to bring to Council's attention a property on Glebelands that has a build up of waste material in the garden front and back. Cllr Jackson took the details and will investigate
- (2) The Secretary of Meadow Rangers FC was concerned about the new ramp at Norton Hill Recreation Ground. The concern was that it is too close to the pitch and could cause a serious injury if a player were to collide with it. It was explained to her that Council will provide mats to cover the ramp during matches, which the teams have to be responsible for putting in place and then putting back in the changing rooms. Also, the pitch may well be moved slightly next season, creating more space for players. She took the comments away and said she would advise players and officers from the league.

167. Apologies for absence

Apologies for absence were received and accepted from Cllr Seaman-Moss who was unwell and Cllr Moss.
