Comments from the public

There were no comments from the public but the Committee noted an e mail from a local resident requesting a zebra crossing or pedestrian right of way at the entrance to Fosse Way School on Longfellow Road. On a daily basis during school times children are at risk from serious accidents due to the disregard of the minibuses which pull into the school. A photo showing a minibus parked on the zig zag lines due to congestion at the school had been circulated. The Clerk was asked to raise this matter with Stefan Chiffers of BANES.

133. Apologies for absence

Apologies for absence were received and accepted from Cllr Appleyard who had another engagement, Cllr Clarke who was unavailable and Cllr Wilkinson who was unwell.

134. Declarations of Interest and dispensations

Item 4, 14/05403/FUL Erection of a workshop to the side of existing workshop – Cllr Cooper declared an interest as this property was close to hers on the industrial estate.

Item 11 Grant Funding – Cllr Butcher declared an interest in that a neighbour was a Church Warden of St Peters Church.

135. Minutes of the last meeting

14/051698/VAR Fosse Way School – The Committee noted that this application was to be determined by BANES Development Control Committee on 14th January 2015.

The Committee discussed the merits of considering the planning applications electronically at the meeting.

Resolved to move entirely to electronic display of planning applications, and to stop receiving paper copies.

137. Planning Decisions

The Planning Decisions were noted. The Committee expressed deep disappointment that 14/03849/OUT Erection of 2 semi detached houses at Hazeldene, Hazel Terrace had been approved dispite the Parish Council's objections.

138. Placemaking Plan

The consultation by BANES on 15th January at Norton Radstock College on the Placemaking Plan for this area was noted. The Committee was disappointed that BANES had not gone further in publicising this event in Westfield and asked the Clerk to try to put up posters in the local shops and get a press release in the Journal the following day.

The Committee discussed the meeting on 5th January relating to the Neighbourhood Plan. A draft application was circulated for consideration. Whilst a Neighbourhood Plan was a daunting task, it was vital for the future of Westfield.

- (3) to continue with the finishing and installation of the noticeboard made by Norton Radstock College and to discuss any payment with them when the board is complete.

The Committee received draft signs for the entrance to the parish.

Norton Hill Football Pitch – to consider stripping back, levelling and returfing the goal mouths instead of re-seeding at the end of the season at a cost of £465.

143. Grant Funding
