## 79. Declarations of Interest

Cllr Newman declared a personal interest in item 6 Planning Application 12/01442/TPO Felling of 7 trees at Old Coal Tip, Wells Road, as he knew the applicants. The Vice Chair, Cllr Appleyard took the Chair for that item.

#### 80. Minutes of the last meeting

The minutes of the meeting held on 12<sup>th</sup> March 2012 were agreed as a true record and signed by the Chairman.

## 81. Matters arising

There were no matters arising from the minutes.

#### 82. Presentation by Sainsburys

The representative from Sainsburys reported that they have a contract with CFH for the sale of their land, conditional upon planning approval. Currently they are consulting widely on the plans prior to an application being submitted. The plans retain a green belt to the rear to protect the residential houses. They include a roundabout at the top of Cobblers Way to address the volume

of traffic and include 470 car parking spaces, a six pump petrol station and service road for lorries, again protected by a green belt.

CFH reported that they started 30 years ago and have a strong commitment to this local area. The plans enable them to invest in the business and create a purpose built facility in the area.

Sainsburys is planning a public exhibition in May at the Community Café in Fosseway School and a Preview event for stakeholders. The Midsomer Norton Store is not closing but will be designated for smaller top up shopping.

Councillors highlighted the need to recognise the store as Sainsburys Westfield and asked if there had been dialogue with the local butchers. Sainsburys confirmed that there had and they were in discussion about the butchers being a supplier to the store. There was not likely to be a pharmacy in the store. Routes to school were being fully considered and appropriate crossings would be installed. The Elm Tree Pub and Total Garage were not part of the land under consideration. Opening hours would be 7am to 10pm Mon to Sat and 10-4 or 11-5 on Sundays. In terms of timeframe it was hoped the store would go live late 2014 or early 2015. The Chairman thanked Sainsburys for their time, the plans so far had elicited a positive response from local people.

The Chairman welcome Kerry Coe and her colleague from Luckington Carnival and, with the Committee's agreement, brought item 12. Fete at Westhill Recreation Ground, up the agenda.

# 83. Fete at Westhill Recreation Ground in June

Kerry Coe outlined Luckington Carnival Club's proposal to hold a Fun Day or Fete at Westhill Recreation Ground on Sunday 24th June 2012 10am to 4pm. The following items had been arranged so far: Displays in zumba, martial arts, majorettes. A wooden horse race, possibly with sponsorship from local businesses. Antique tractors, Somerset Carnival Van, PCSO's and the Community bus, Fire brigade and chip pan display. Cllr Appleyard agreed to contact Chris Revell of the adapted bikes. In terms of food there was to be a barbecue run as a fund raiser by Luckington Carnival Club and a Doughnuts van. There was to be a bouncy castle, slide and obstacle course, junior octopus ride and sledge hammer. Wansdyke Play Association was to be contacted for the Climbing Wall and Blue Bus. Westhill Club was very supportive, providing electrics and toilets. A joint litter pick at the end of the day would be arranged together with a free mini skip. St Johns Ambulance was invited for First Aid. There would be no stewards but Councillors were asked if they would be present on the day to help out on the field. A jubilee themed fancy dress competition might be arranged, to be judged by the Carnival Court. Extra insurance cover would be needed for a BMX display and the Clerk agreed to look into this item. Signs saying 'no alcohol on the field' would be on display. Kerry agreed to attend the May Environment and Development Committee meeting to go over the final plans.
