#### 38. Apologies for Absence

#### 39. **Declarations of Interest**

- Cllr S Hamilton declared an interest, as a family member, in item 6, Area of Green Space dedicated to the memory of Chris Cray.
- Clirs R Applevard and S Hamilton declared an interest, as members of the Avon Pension Fund, in item 8, Avon Pension Fund.

#### 41. Drop in Café for young people

The Council noted that PCSO Carol Lawrence was unable to attend but that an outline of her initiative for a Youth Café was circulated. This would replicate the tea and trade café held one evening a week in Radstock, run by a Youth Worker. It was noted that the Methodist Church was looking to set up a similar initiative on a Tuesday night and was looking for volunteers. It was agreed to move this item to the September Parish Council agenda.

# 43. Area of green space dedicated to the memory of Chris Cray

The Council considered the recommendation from the Finance and Personnel Committee that the voluntary planters be supported with the funding for a sign on the area of green space at the junction of Cedar Terrace and Wells Road in memory of Chris Cray. The Clerk confrirmed that comparative quotes had been sought and funding in the sum of £120 should cover the cost of the sign and its fixing. CURO had offered financial assistance as well, which it was hoped would cover the cost of the plants.

RESOLVED to agree the recommendation of the Finance and Personnel Committee that the voluntary planting, led by Cllr Hamilton, be supported and that funding for a sign in the region of £120 including fixing, be agreed.

# 44. Area of Hardstanding to the rear of the Tennis Court, Norton Hill Recreation Ground

The Council discussed the project to enhance sports at Norton Hill Recreation Ground with a petanque court, table tennis table and basket ball hoop, and tarmacking of the grounds.

RESOLVED (1) The Child Protection Policy as circulated be agreed; (2) The Delivery Programme as circulated be agreed; (3) that the Parish Council would meet the costs of the project which are not otherwise met by other grant funding, up to £12,040; (4) the Sport England application be submitted accordingly.

### 45. Avon Pension Fund

The Chairman reported on a forthcoming flag ceremony in Taunton which he was unable to attend.

The Chairman reported the path from Elm Tree Avenue to Perry Close suffered from dog mess and asked if it was to be an emergency access. Cllr Appleyard confirmed it was not an emergency access and the bollards were to be replaced with permanent ones. He advised it was worth looking at dog walking routes before installing a dog bin, with the associated emptying costs.

### 49. Bath and North East Somerset Councillors' Report

Cllr Appleyard reported that the Core Strategy is under consultation and that the Ward Councillors were having discussions about the current 5-6 week grass cutting cycle.
