41. **Westfield Walkers**

42. **Westhill Sports and Social Club**

Communication is awaited from Westhill Sports and Social Club to set up a working group to explore the possibility of a community facility at the site.

43. **Christmas Lights Switch On Event**

It was noted that portable lighting has been arranged, as has a portable manual switch for the turning on of the lights at the event. Also the lights around the local shops are now controlled from one switch instead of individual light switches for each shop, which created anomalies in turning on and off times last year. It was further noted that, as agreed by F&P earlier in the year, a lighting point has been added to the roof of the Pharmacy, where a tree can be located this year

The Committee received the results of the initial public consultation on 19th June and expressed its continued support of the Questers' work.

49. Request for a Fun Fair at Norton Hill Recreation Ground in September

The Committee discussed a request for a Fun Fair at Norton Hill Recreation Ground. In principle Norton Hill is a much better venue for a fun fair than Westhill Recreation Ground because the houses are not so near.

RESOLVED to invite Mr Rogers to meet Cllr Fuller and any other interested Councillors on site to discuss (1) whether the gates were too narrow to allow in the fun fair vehicles; (2) the risk to the football ground so close to the start of the football season and whether this event could be booked in for May/June 2014; (3) stewarding needs; (4) details of the guarantee bond on the ground.

50. Correspondence from Mr P Greenwood

The Committee received correspondence from Mr Greenwood and his request that the Parish Council considers liaising with Westfield Primary School to allow children to enter and exit the school at the beginning and end of the school day via the double gates opposite the traffic lights on Cobblers Way in order to avoid the danger of children walking on narrow footpaths with heavy

traffic at Westfield Primary School.

The Committee discussed the imminent permanent smiley face speed indicator device and the speed camera points to be positioned further down the road. Opening the double gates to the children would take the pressure off the foot traffic at the corner, but would create the need for a footpath across the grass into the school and a person from the school to open and close the gates.

RESOLVED to raise with the Head Teacher Mr Greenwood's suggestion and to discuss any other ideas to help improve the safety for children such as more railings.
