## **COMMENTS FROM THE PUBLIC**

The meeting was addressed by Mr Craig Haskins and Mr Nick Haskins, who have applied for planning permission to turn a unit on the Westfield Industrial Estate into a soft play centre. Mr Nick Haskins has been advised by the Planning Officer that planning permission is unlikely to be given as it is a protected employment building. They gave a presentation on the proposed unit, advising that they will employ 7 people, full time and part time, offering permanent contracts. They will provide a free to use community space, and have part of the unit available to other small businesses like hairdressers. The unit is currently empty and the tenant has been advertising it as available since April 2015.

They requested support from the Parish Council for their application. Committee advised that we had raised no objection to the plan when considered last month. The committee resolved to support the application. Cllr Jackson advised of a meeting she had scheduled with the Planning Officer the next day and would relay the Council's support.

17/00498/FUL - Erection of conservatory and rebuilding of new shed, following demolition of existing. 10 Welton Road.

As we believe the extension is not contrary to policy D.4 we have no objections to this application

17/00699/FUL - Erection of a single storey side extension. 35 Waterside Way

It was agreed there would be no objection following a vote with 4 in favour, none against and 3 abstentions.

17/00874/TCA - Birch - fell. Willow – at the moment it stands around 10m high. Bring down to 3m. 45 Welton Road

There were no objections to this application

17/00998/TCA - Group of Sycamore to the rear of Green Gables, Wells Road – fell stem

There were no objections to this application

16/04714/FUL - Revised application. Approval of reserved matters with regard to outline application 14/04003/OUT for the erection of 81no. residential dwellings and associated works. Cobblers Way

The committee objected to this application on the grounds of inadequate parking and garage space, unsatisfactory layout and overdevelopment. It was noted that should the officer be of a mind to permit we would like the issues raised in the urban design report resolved.

#### 180. CONSULTATION ON B&NES PARKING

**Resolved:** to respond to the consultation, reiterating the previous objections to (1) the proposed limited parking times at the shops at Elm Tree Avenue; (2) the length of the no parking restriction proposed on Elm Tree Avenue, which should not go as far as the houses; (3) the request for the no parking restriction to be extended on St Peter's Road.

In addition, (1) to object to the proposed no parking on First Avenue as it was not felt to be necessary; (2) to request double yellow lines on Cobblers Way, close to the traffic lights. Residents should use the parking at the rear of their houses. Parking so close to the junction was dangerous to vehicles turning in to the road; and (3) to request 30 yards of double yellow lines at Welton Road as you turn in on the same side as the Rookery.
