#### Comments from the public

One member of the public expressed her deep dissatisfaction with the parking situation at Larch Court. The top end of Larch Court has garages and allotted parking spaces, but some people park in the road anyway, which is part of the problem. There are cars on pavements and the grass area and some driving over the footpath and across the bottom of gardens to park on the grass. She would like to see the cars stopped from parking on the grass and pavement. She would like to see the car parking situation sorted out, but not parking provided on the grass. There followed a discussion on whether the grass area at the back was possible for parking but it was felt that access was not wide enough and even if it was, it was not certain whether people would leave their cars there.

Another member of the public also expressed his deep concerns over the parking situation however he would like to see the grass area at the front converted in part where it juts out to parking, with spaces allotted to certain houses, to help relieve the problem. The Chair thanked everyone for their comments and said that they would be conveyed to BANES for consideration. It was noted that BANES had acknowledged receipt of the petition and conducted a search of the land in question and found that it belongs to Taylor Wimpey. They had therefore forwarded the petition and the concerns to them.

In addition, facilities such as doctors surgeries and schools would not accommodate such an increase in local housing.

The Parish Council itself would have a gazebo with mince pies and possibly mulled wine. The next meeting of the group would be on 12<sup>th</sup> May at 6.30pm immediately prior to the E&D meeting.

### 190. Former Tennis Court at Norton Hill

The Committee received a verbal update on work at this site. Cllr Cooper was purchasing some sports equipment to the value of £26 for the open day which looked as if it might be in the week commencing 19<sup>th</sup> May and she asked if the Fun Fair might be arranged for that week.

#### 191. Noticeboards

It was noted that the noticeboard would be ready in late May and the Council had agreed that it should be located next to the post box, so as not to block the view from the other side. Its cost was between £350 and £400.

#### 192. Gap in Yellow Lines at St Peters Road

Cllr Butcher reported that Stefan Chiffers was aware of the problem and it was awaiting consideration.

#### 193. Items for the next agenda

Former Tennis Court; Noticeboard; Dropped kerbs – to seek support from the BANES Councillors for a reduction in fees for dropped kerbs given that the drives are built without dropped kerbs and many people are in social housing and the fees put this work out of reach.
