104. GRASS CUTTING IN WESTFIELD

The report from the Clerk was noted. In addition feedback was given on a meeting with B&NES' Parks team on 14th November. Parks were currently undertaking a review of their grass cutting and had purchased new machinery. The option to take over the service in return for a grant was broached at the B&NES meeting. There are no arrangements of this nature yet in B&NES. E&D suggested that the Parish Council should open a dialogue with Cllr Charles Gerrish, cabinet member for Finance and Efficiency.

 - b) to continue to talk to B&NES about the logistics of a devolved service agreement;
 - c) to open a dialogue with Curo about their grass cutting.
