- (ii) To build up Parish Council funding and seek grant funding over the next two years to a level of £40,000 which should allow £15,000 for surfacing and £25,000 for play equipment;
- (iii) At the appropriate time to go out to the local manufacturers for their play area designs to meet the aspirations of the local children

# 13. <u>Area of hard standing next to the Tennis Court at Norton Hill Recreation</u> <u>Ground</u>

Members considered recommendations from the Environment & Development Committee regarding the proposed potential use of this site which despite recent weed clearance was rapidly reverting back and needed to be addressed urgently.

  - (d) Basket Ball Hoop
  - (e) Tarmacing
- 2) That consideration would need to be given to amending the landscape contract next year to include these improvements
