## 22. Westfield Play Area – monies outstanding

# 23. Green Space area - Dedicated to the memory of Chris Cray

Members considered a request for funding towards establishing an area of green space at the junction of Cedar Terrace and Wells Road which Curo had agreed may be dedicated to the memory of Chris Cray.

A recommendation be made to the Parish Council that the voluntary planting, led by Councillor Hamilton, should be supported and that funding for a sign in the region of £120 be provided, with comparative quotes sought.

# 24. <u>Area of hard standing next to the Tennis Court at Norton Hill Recreation Ground</u>

Members were advised that funding would be applied for from Sport England to the value of £8,150 which would cover the cost of equipment required. Additional extra fencing cost is anticipated behind the basketball hoop with a prediction that the whole project should cost in the region of £20,000

- 3) That quotations be obtained in respect of the proposed additional fencing costs.
