1. Apologies for absence were received from Cllr Bryan Wallbridge.

- 2. Declarations of interest and dispensations there were none.
- **3. Minutes of the last meeting** held on 4th February 2019 were agreed as a true record.

4. Draft bid for funding for feasibility studies

The draft bid was **agreed** and it would be submitted once Sustrans has come back with a quote for an Engineering Feasibility Study for the Roman Road footpath and (2) the stand alone pavilion feasibility tender at Westhill Recreation Ground has been agreed by Parish Council.

With regard to the Stand alone Pavilion at Westhill, it was **agreed** that there should be a conversation with planners before funds are spent on the feasibility study. It was noted that it should be designed with no dark areas such as alleys at the side or behind the facility. It was suggested that a solid wall at the back of the Pavilion might replace the trees, with a tree replanting scheme to balance the loss. CCTV should be incorporated into the design.

5. Links to websites about inclusive play

The links were discussed and there was a discussion on how some of the concepts might be introduced in Westfield. The multi functionality of green spaces was considered – how they might have different uses at different times of day by different people. For example a 1.5m track around the perimeter of Westhill Recreation Ground would make the field accessible to those in wheelchairs and mobility scooters, it might be used by dog walkers, running groups, the elderly, families and children on scooters. Introducing activities or exercise points for people of different abilities and ages at points along the track would support the multi functionality of the grounds.

6. Items for the next agenda

The following list of opportunities for enhancing green and open space was drawn up at the meeting. Action points would followed up by all members of the Working Group outside the meeting and brought back for a progress report.
