The minutes of the NPWG meeting of 23rd January 2017 and 27th February 2017 were received. Cllr Hopkins reported that the section on Employment, Industry and Jobs was complete, the sheer volume of work was daunting but it was progressing in stages.

167. FUN FAIR AT NORTON HILL RECREATION GROUND

The Council received the Fun Fair report.

Resolved

- (1) that the Fun Fair may hire Norton Hill Recreation Ground for 9 days maximum (14th May 22nd May, 4 days set up/take down, 5 days operational);
- (2) that the items to mitigate risk set out in the report be agreed; (3) that, whilst the bond of £1,300 was reasonable, the hire fee be delegated to the F&P Committee for decision at its next meeting.

168. CHANGING ROOMS AT WESTHILL RECREATION GROUND

The Council discussed the request for grant funds for the Changing Rooms at Westhill Recreation Ground.

Resolved

That a grant of £1,000 be awarded to Westhill Club for the repairs to the showers in the changing room, on condition that three quotes be sought first for the work.

169. OUTSIDE BODIES REPORTS

Cllr Jackson gave a brief update on the Museum and Cllr Cooper noted that items were awaiting consideration in relation to Mardons.

170. CHAIRMAN'S REPORT

The Council discussed the remit of the Boundary Commission and whether the Parish Council might like to recommend any changes. The matter to be put on the next E&D Agenda.

171. BANES COUNCILLORS' REPORTS

Cllr Jackson reported that a 3.5% Council tax rise had been passed by B&NES. Adult social care, youth services and library services were some of the areas of concern.
