bring BaNES attention to the need for restrictions on parking in the area. He made note of the situation and agreed areas that lines would be replenished or increased on Longfellow Road and surrounding roads.

Cllr Jackson also spent some time with Ashley Ayres, the Chief Executive of BaNES, showing him around Westfield and pointing out some issues of concern for residents.

There is an amendment in place to delay the decision on awarding community health and social care services to Virgin Care. At present there are two public meetings on Thursday 10th November to present the detailed document to BaNES Full Council and CCG Board.

115. WESTHILL SPORTS AND COMMUNITY CENTRE

Part of the discussion at the Neighbourhood Planning meeting was about the feasibility study for a community centre in Westfield. It was put forward that Westhill Sports and Community Centre would be an ideal place to have such a centre. Cllr Wilkinson proposed that a meeting is set up with the Committee of the club and move forward with discussions. Cllr Hopkins seconded.

116. s.106 SPENDING IN WESTFIELD

Clir Moss has been in discussion with Clir Tim Warren and Mr Ashley Ayres, Chief Executive of BaNES about s106 or ClL money that should be available to be spent in Westfield and is to raise it at Cabinet and Council meetings. It is a point of principle that s106 money is available to recognise the effect on a community of a large development. North East Somerset subsidises Bath with its town and parish precepts, if s.106 spending takes place outside of our community then this is a double hit. Had any consultation on Midsomer Norton Town Park taken place outlining the fact that s.106 funds in Westfield were to be diverted to this facility, then the Parish Council would have strongly objected. BANES has a policy on children's play areas. Diverting funds to a park which can only be accessed by car goes against their policy. The Parish Charter puts an onus on BANES to inform the towns and parishes – this has not happened in respect of s.106 spending in this area. Therefore BaNES' action appears to breach the Parish Charter and their own Policies.

Resolved: (1) To investigate the possibility of a judicial review;

(2) to arrange a meeting with the Chair and Catherine Parker and Lisa Bartlett of BANES.
