# **Comments from the Public**

Val King who, along with Dave Fishlock, is the owner of the Shambles, attended to give a presentation on proposals for this site. The original application was refused and the site is now a non designated heritage asset, meaning that there is now some governance by the Conservation Officer. Proposals involve retaining the roadside façade; removing the retail shop fronts, taking it back to the original cottage frontages; and knocking down what is behind for housing and commercial space. There are 11 car parking spaces in total and 6 proposed residential units (to be tenanted). The Parish Council commented that there appears to be a greater need for small housing units than office space in this area and queried whether they would have difficulty letting the office space.

Cllr Butcher arrived at 7.10pm.

Lynne Waton, Church Warden for St Peters Church attended to outline plans for the renovation of the St Peters hall roof. The roof went up in the 1950's with an expected life of 25 years. It has had various work over the years but is now not waterproof and, given that the hall is used extensively, the situation is critical. Mrs Waton asked that this application be supported.

# 110. PHONE BOX AT CHARLTON ROAD

The Committee thanked Cllr Cooper for investigating the costs of moving the phone box at Charlton Road, using local contractors and renovating it at a cost of £2,000 plus the costs of making good the site. There followed a detailed discussion on the potential usage and the historic value of keeping this 1935 phone box, together with the fact that there is a working public phone in a booth outside the Co-op at Elm Tree Avenue.

**Resolved:** that the Clerk contacts BT about the possibility of the Parish Council moving the Charlton Road phone box and resiting it to house the existing public phone outside the Co op.
