Mr Perrett, Chair of Radstock Residents Association, wished to approach us concerning the maintenance, (grass cutting) at St Nicholas Church, Radstock. The Rector, Sue Greatorex asked his Association for help. There is a shortfall in funding. The impression was that the support last year and the year before from Radstock and Westfield Councils was not assured. £6,000 would keep the place ship shape and the Church has a shortfall of £4,000. The Church is used by Radstock and Westfield Residents and if they cannot get funding they would have to raise charges which they want to avoid doing. At present they pay two gardeners for 10 hours a week although they work a lot more than 10 hours.

The Chair recommended that a Grant form be sent to him for the current year and thanked Mr Perrett for attending the meeting.

Apologies were received from Cllr Appleyard who had another meeting and Cllr Butcher who had another appointment.

36. Chairman's Report

The Chair reported that he and the Parish Clerk had met with Stefan Chiffers, from Highways in B&NES. We will now be getting a smiley speed sign which will be going up by Westfield School in due course. The sign will be able to turn both ways. Whilst walking around with Stefan he indicated that he would put lines in the turning circle at Elm Tree Avenue and appropriate signage. He was asked if a hardstanding could be put in on the side of the road by the Christmas tree for a mobile speed camera.

The flags above the shops will be going up tomorrow.

Before the meeting Lesley, Robin and the Chair had photos taken receiving a defibrillator for Westfield which is sited outside the Chemist in Elm Tree Avenue. It cost a lot of money and this will be a great asset for the community. It has to be checked on a weekly basis which will need a rota system. A Press Release regarding the defibrillator will be sent out shortly thanking all those involved.

The grass has now been cut and gravel placed around the Christmas tree.

37. Bath and North East Somerset Councillors' Report

Cllr Moss thanked Geoff and the Clerk for their help in letting Radstock Town Council borrow Westfield's St George's flag. He believes that Radstock have now been donated a flag.

Nothing has been heard from Sainsbury's so it looks like they are not going to appeal.

Cllr Hamilton asked if any progress has been made regarding the different owners of the Pit Path as it was looking a mess. Cllr Moss felt that the Parish Council should take responsibility for writing to B&NES and the other owners
