# Comments from the public

The planning application from Fosse Way School for a Post 16 Teaching Block raised serious concerns given that 75-100 cars related to the school already park in surrounding roads. The Parish Council had obtained an extension to allow the application to be considered at its meeting on 13<sup>th</sup> January. The residents obtained an extension until 23<sup>rd</sup> January to allow wider consultation, and would like longer to allow all residents time to consider the application. There was a discussion about the fact that the Sixth Form started in September 2012 and will be increasing its number of pupils, meaning that more staff will attend, or that existing staff will be parking for longer hours causing more congestion. Parking on site was essential.
