#### **Public Comments**

The Chair welcomed Steve Collins, Chair of the Midsomer Norton and District Carnival Association for an update on the development of the Carnival.

Steve Collins thanked the Council for their support and hoped it would continue. He explained that times were changing in Carnival to benefit the local area. The Carnival held a public meeting to discuss what changes needed to happen and an independent committee was set up to look at making the Carnival better for the whole community, with three main objectives, i) better park up area away from residents; ii) a dispersal area with slightly more space, iii) for the route to include Midsomer Norton, Westfield and Radstock. This committee has been meeting every two weeks since the beginning of the year.

Last month we had a meeting with BANES Safety Advisory Team and the Police who are happy with the new route which we will be trialling in November.

As Bridgwater has now changed its day to a Saturday this opens up an opportunity to hold our carnival on the second Monday, which should encourage more floats to come and bring more people in, perhaps even from the Bath area.

The proposed new route to include all three towns would start at the Centurion roundabout go down Charlton Road, into Silver Street and up Midsomer Norton High Street the wrong way and right towards Radstock. There will be a resting area and then it would be up Wells Hill into Westfield and just past Westfield Methodist Church.

The Council discussed this proposal in the light of the Trust Deed restrictions outlined in the Conveyance of 1942.

the business hub and a new Committee be set up with the Chair and Vice Chair of Council, Chair of Environment and Development and Chair of Finance and Personnel to

look into other possibilities.
