191. FEASIBILITY STUDY FOR A STAND ALONE PAVILION AT WESTHILL RECREATION GROUND

Andrew Barnes had been unable to attend a meeting with Councillors prior to this meeting. It was recommended that Council should approach BaNES planning department to assess the likelihood of planning being permitted before doing a feasibility study on the building itself.

Resolved: (1) to contact BaNES to establish whether the application would benefit from pre-application advice before taking the feasibility study further.

192. CREATING COMMUNITY IDENTITY

a. HAYDON BATCH

Cllr Fuller reported on a meeting with Radstock Town Council, who have purchased land at the batch, regarding their request to put a dog mess bin and a gate on land which is in the parish of Westfield.

Resolved: to advise Radstock Town Council that Westfield Parish Council has no objections to putting a dog mess bin and a gate on the land

b. WESTFIELD WARBLER

It was noted that Ignyte will no longer be delivering the Warbler, and that Mr Bob Wilkinson has agreed to deliver the May issue. The Chair thanked Mr Wilkinson.

The Clerk is currently looking for person(s) to take on the delivery from August.

c. POSTAL ADDRESSES IN WESTFIELD

The result of the consultation was noted, along with a letter from Royal Mail outlining the main reasons that objectors to the project gave.

These objections fell mainly into three categories:

- a. The address has always been Midsomer Norton or Radstock and consultees do not want an address change
- b. Consultees saw the cost and inconvenience of informing contacts and updating stationery, signage and livery etc.
- c. It was felt that any change will lead to confusion for people trying to locate the area.

Councillors considered the objections, which related to 7.26% of those contacted. The threshold for the Post Office to uphold objections is 20%.

Resolved: to contact the Post Office and ask to go ahead with the locality change for addresses in Westfield.

193. OUTSIDE BODIES REPORT

Mardons – Cllr Cooper reported that Mardons were pleased to have had a meeting with an enforcement officer from BaNES and were waiting for his report.

194. CHAIRMAN'S REPORT

Cllr Fuller noted that this was the last meeting of the current Council, before the election in May. He thanked all Councillors for their work over the time they had been in office, and thanked the office staff for their support. Cllr Mansell advised that she would not be standing for election in Westfield, but thanked all Councillors for their support, saying the Council had been a pleasure to work with.

Cllr Jackson gave apologies from Cllr Moss, who had been hoping to attend this evening. She praised the Council for everything that had been achieved, with special regard to the Neighbourhood Plan and said that it had been a delight to work with Westfield Parish Council. The Chair thanked Cllr Jackson for all her work as BaNES Councillor.
