**Trinity Methodist Church, Radstock,** is to hold a Christmas Tree Festival for which Council is invited to provide and decorate a tree.

**RAWDAG** – There was some discussion about how it has been difficult to have access to the funds that were made available initially for economic development in Westfield and Radstock. Areas which need funding are the car park on the Westfield Trading Estate, Community Centre or changing rooms at Westhill and the toilet at Trinity Methodist Church Westfield.

**Resolved:** to send a letter from the Chairman to Andrew Pate of BANES advising that Westfield has some projects that would benefit from the funding.

## 101. CHAIRMAN'S REPORT

Cllr Fuller reported that on September 16<sup>th</sup> he led a heritage walk in Westfield as part of the Somer Valley Walking festival and that it has been very successful, with people from outside Westfield coming along as well. He advised that Cllr Hopkins is to stand in for him at the Remembrance service and the Christmas lights switch on this year. Cllr Hopkins responded that he is honoured to do so.

Cllr Fuller also reported on the History of Westfield exhibition opening ceremony, which was attended by Michael Eavis, as having been a success. He encouraged all Councillors to visit the exhibition.

# 102. B&NES COUNCILLOR'S REPORT

Cllr Jackson reported that she is still liaising with BaNES to have a litter bin placed by the Trinity Methodist church on Wells Road. She reported her concerns about residential care and mental health provision for children. It was noted that a WW2 pill box had been bought and demolished by a resident.

**Resolved:** to write a strong letter to BaNES that could be used to ask English Heritage to list the other pill boxes as a matter of urgency.

Street lighting – 4 areas of concern have been given to BaNES to consider. It was noted that an officer is attending Kingsley Avenue this evening to address a resident's concerns.

The youth shelter was discussed as there has been a lot of damage to it. It had been moved at the suggestion of the police from Westhill. There has been some concern from the Bowls club that the behaviour of those using the shelter could spill over to the club.

**Resolved:** to write to the police to advise that there appears to be a lot of anti-social behaviour at the shelter, and ask that they monitor it closely.
