#### 71. DECLARATIONS OF INTEREST AND DISPENSATIONS

Cllr Jackson declared an interest in item 7 – Planning application for RADCO - as a shareholder and as a member of the BaNES Planning Committee.

Cllr Hopkins declared an interest in item 7 – Planning application for RADCO - as his property borders the RADCO land and in item 11 – Youth Cluster Group – as Chairman of the Board of Youth Connect South West.

# 72. MINUTES OF THE ANNUAL PARISH COUNCIL MEETING – 1st July 2019

# 73. TO WELCOME REV'D IAN ROUSELL

Rev'd Ian Rousell attended the meeting in order to introduce himself to Councillors as reverend of St Peter's Church in Westfield. He said that he felt that in Westfield there was a lack of community, and was interested to see that on the agenda there is a running item – Creating Community identity. It was explained to Rev'd Rousell that this is a running item as the parish is quite new in its inception and the Council works hard to make residents feel part of the parish. Rev'd Rousell welcomed that and said that in the two years that he has been reverend at St Peter's the church is growing and becoming a more fun place to be. He finished by saying all are welcome.

# 75. APPROVAL OF ANY ITEMS OF £5,000 AND CONSIDERATION OF ANY VIREMENT

Cllr Jackson proposed to accept the budget of up to £3,000 for the VE Day commemorative event on May 8<sup>th</sup> 2020 and Cllr Wallbridge seconded. All were in favour.

**Resolved:** (1) To allocate up to £3,000 for VE Day commemoration from 4232/202 "Community Projects" and EMR 330 "Community Fund".

(2) To ratify payment of £7005.45 + VAT to Theme Bins International Ltd for new benches at Norton Hill as approved on 1<sup>st</sup> July, to be funded from B&NES s.106 funds.

# 76. PLANNING APPLICATION 18/05623/OUT – Cooperative Store A, Wells Road

The revised planning application was discussed and Councillors agreed the following:

Westfield Parish Council wholeheartedly supports the planning application on the grounds that (1) it enhances the Conservation Area, (2) it provides better working conditions for the employees and (3) it gives improved accommodation for local residents.

#### 79. VE DAY 75 WORKING GROUP

The following points from the meeting on 2<sup>nd</sup> September were noted.

- 1. Vehicles Ron Hopkins mentioned that World War II vehicles might be loaned from the Haynes Museum.
- 2. Eleanor Jackson to contact Peter Yates of Double Hills
- 3. Vince Cox played Churchill's two minute speech declaring Victory in Europe.

  The Clerk to contact BBC Somerset Archives to request a copy of the speech on cd.
- 4. The Clerk to contact Strode Sounds for a quote to book a sound system for 3pm on 8<sup>th</sup> May 2020.
- 5. Memorial Artefact The Clerk to respond to Bath College asking them for budget bandings which tell us what might be achieved in each banding so that we can go out for funding.
- 6. Games played by children in the war years Joan Pack to research
- 7. The Clerk to write to the schools, clubs and groups in the area letting them know of the event and asking if they would like to take part by running an activity of some kind and/or dressing in 1940's clothes.
- 8. The Clerk to contact the Silver Band and Westfield Voices for their availability to play/sing at 3pm on 8<sup>th</sup> May 2020.
- 9. Food Joan Pack to look into whether the Methodist Church might make some of the war time recipes to be handed out as tasters on the day. James Honess and Vince Cox offered to look further into offering refreshments.
- 10. Publicity Joan Pack has an original VE Day Flag and would liaise with the Clerk regarding an article in the next Westfield Warbler.
- 11. Road Closure might be necessary on Elm Tree Avenue from its junction with Wells Road to Waterside Road.
- 12. Events Licence to hold off on this for now until the venue is confirmed.

### 85. OUTSIDE BODIES REPORTS

It was reported that the Big Local are supporting youth work in Radstock and Westfield and that Youth Connect are putting together a bid to fund a full time Youth Worker based at Writhlington and Norton Hill schools. The question had been raised about whether Radstock Town Council and Westfield Parish Council would like to partners in the project, which would include being invited to meetings to determine what goes into the bid.

# 86. CHAIRMAN'S REPORT

Cllr Fuller reported that he will be leading a walk around Westfield as part of the Somer Valley Walking Festival on Saturday September 14<sup>th</sup> at 2pm, starting at the shops on Elm Tree Avenue. All are welcome to join in.

The benches and tables at Norton Hill Recreation Ground are nearly all installed now and they are already very well used. There has been a lot of positive feedback. Cllr Fuller gave thanks to the Green and Open Spaces Working Group for their work on the project.

#### 87. B&NES COUNCILLORS' REPORTS

Cllr Jackson reported on a visit from Cllr Neil Butters of B&NES, Cabinet member for Transport Services, to Longfellow Road to see the difficult situation that arises with inconsiderate parking along the road. She is shortly to have a meeting with Cllr Paul Crossley, Cabinet member for Communities, to discuss providing something for the young people of Westfield.

The Infringement Officer investigating the situation at Mardons has found that Linden Homes were required to have the 14 offices "fitted and usable" which hasn't been done.

The Civic Service for Cllr Jackson being sworn in as Chair of B&NES took place in July. Westfield Voices took part.
