47. **CREATING COMMUNITY IDENTITY**

Cllr Jackson reported a positive meeting with the Principal of Bath College, who is keen to develop links with the Parish Council. The College are interested in creating a piece of artwork to be located at an outside space in Westfield.

Discussion was held about how to commemorate Westfield residents that gave their lives in wartime, or contributed to the war effort in various ways.

 - (2) to include the item on the October agenda for Full Council, after responses have been collated, for further discussion.
