# **Comments from the public**

A member of the public spoke about the new LED streetlights which compromise safety due to the lack of spread of the light and the fact that they are further dimmed at about 11pm. There are an extra 4 or 5 LED lights installed at Longfellow Road, presumably for the safety of the school. More of such lights are needed.

With the agreement of the Council, items 4 Sugar Smart and 16 Chairmans Report were brought up the agenda.

#### 72. SUGAR SMART

The Chairman welcomed Sophie Kirk who works in the realms of Public Health and Sustainability at BANES. Sophie outlined the Sugar Smart campaign which aims to help the community make informed choices about hidden sugars. It is a two year campaign and she asked for the Parish Council's support in terms of promotion in the newsletter, circulating resource packs, highlighting the grant opportunities, getting involved in events, promoting the sugar smart quiz and raising awareness. The Parish Council invited Sugar Smart to the Westfield Fun Day on 3<sup>rd</sup> June 2018, requested an article for the Warbler and suggested that the Youth Service takes the Quiz.

#### 73. CHAIRMAN'S REPORT

The Chairman welcomed a member of the public who is looking to open a Tea Room at 3 Elm Tree Avenue. There was a discussion on the lease arrangements with CURO and Cllr Jackson agreed to seek further clarity.

Areas of particular concern due to lack of light are Linden Close, Elm Tree Avenue, Inner Elm Terrace, Glebelands. Cllr Jackson reported that BANES Officers are coming out to look at the situation.
