Cllr Moss reported on what has been happening with the fund so far: A hot square meal project, Family weekly food project and Small stuff baby bank project are underway at a cost of £15,000. There have been discussions with Becky Brookes of the Journal to pay for advertising for businesses in the area once things get back to normal. Another suggestion was for street parties to bring people together. Cllr Moss will suggest that to the Big Local. Cllr Hopkins said that this money was not only available for funding during the virus outbreak but afterwards as well and welcomed any suggestions for spending from Councillors.
