Minutes of the Meeting of the Council held at the Boardroom, The Oval Office, Cobblers Way, Westfield on Monday 6th November 2017 commencing at 7.00pm

Mr Mike Martin and Revd Jan Tate of Trinity Methodist Church, Westfield, attended the meeting to explain their case for the grant towards improvements needed in the church hall. This is minuted in item 112 – Support for a request for funds from the Fredericks Foundation from Trinity Methodist Church, Westfield

Mr John Hamer stood, representing the Neighbourhood Watch scheme on Welton Road. He reported concern from residents regarding the traffic on Welton Road. Vehicles are using the road as a rat run and take no notice of the speed limit of 20mph. The addition of a construction centre at the Bath College has increased by 500 the number of students attending the college, which has increased the traffic and pedestrians on the road considerably. He has had discussions with Stefan Chiffers of BaNES, who has recommended a feasibility study, but has said that it will cost around £5,000 and BaNES don't have the budget for it. Mr Hamer is attending a committee meeting at BaNES on Thursday to highlight the concerns.

A resident of Longfellow Road stood to explain to Council his concerns regarding inconsiderate parking on the road, into Wesley Avenue, by people who are using the school. He pointed out that minibuses and taxis are using Wesley Avenue and Longfellow Road as a route to the school and not using the main road, which is causing extra strain on the area. Another resident of Longfellow Road said that the 20mph limit is regularly ignored and that people are parking on the bus stop there and on Wesley Avenue. He wondered why staff from the café at Fosse Way school have been asking for sponsorship, raising concerns that they are looking to increase business, leading to more problems with parking. He also pointed out that there is to be a large development of houses in Westfield, which will impact on the school.

107. BUSINESS ENGAGEMENT WORK IN WESTFIELD

The Council welcomed Duncan Kerr, Business Growth Team Leader in BANES. Mr Kerr said that he was attending the meeting as information sharing and a call to action for the Council to alert his team to any requests for assistance from local businesses in Westfield. He advised that Sara Dixon has alerted him to the traffic conditions on Westfield Industrial Estate and that Biggs has been approached with regard to extending the car parking facilities on site. He explained that his team are starting to get the resources needed to, hopefully, be able to help businesses on the estate.

He reported that in his discussions with business owners it became apparent that broadband connectivity was an issue that needs to be addressed and advised that there is a voucher scheme that can be accessed with a pot of £2m available to bid for a share of.

It was pointed out that infrastructure is an issue in Westfield and that fast broadband schemes were vital to enable access for businesses.

Mardons – Cllr Cooper reported that there is a problem with the number of young people that are gathering outside Mardon's club, who are not there because of the club, but that it is a convenient place to congregate. There has been some anti-social behaviour at the gatherings, with car windscreens being smashed. PC Mark Graham has been called out and has spoken to the youths. Bill Stevenson of the club has also spoken to them and the situation seems to have abated slightly. The club said that if they report to the police they always get a good response. However, on this occasion it has not alleviated the problem
