*Westfield In Bloom* – Cllr Jackson reported on the recent success in this year's awards. The allotment society, Westfield Primary School and Fosseway School were all awarded Outstanding. Westfield Primary School are now recognised as a Champion School within B&NES.

# 93. Bath and North East Somerset Councillors' reports

Cllr Jackson reported:

- I have missed a number of my regular 'surgeries' at Trinity Methodist Church, most recently because of fund-raising events in the afternoon meaning the hall was shut mornings.
- I have been busy with Westfield in Bloom, which I believe is very important for creating community cohesion, identity and morale.
- Unfortunately, the Local Plan process has been halted, which makes Westfield vulnerable to speculative developments I did my best to represent your views individually at the Planning Inspector's Enquiry into the Curo application.
- We should see the consultation process of RADCO begin in January.
- I have devoted a lot of time to the recent Police and Crime Commissioner's visit. She met Sam Plummer of Youth Connect South West, who spoke highly of our support and the work he was endeavouring to do in Westfield

- 2) When meeting with the Architect, we touched on the possibility of demolishing the existing building and re-building as a stand-alone structure on the same footprint from scratch. The Parish Council agreed to go ahead with this option.
- 3) The Clerk to arrange another meeting with the Architect to iron out all the items they require in order to write a spec.
- 4) The Funding Matrix was noted and it was agreed to fund from reserves and grants with the balance via a PWLB loan of 15 to 20 years.
